Item No. 3 : Appointment of Panel of Advocates in High Court of Bombay bench at Mumbai, Aurangabad and Nagpur and fixation of their fees.

The Secretary, Admissions Regulating Authority emphasized on need of panel of Advocates in all the three benches viz Mumbai, Aurangabad and Nagpur Bench of Bombay High Court, w.r.t. no. of petitions filed against the Admissions Regulating Authority and/or the State CET CELL. Hence it has become necessary to appoint separate panel of Advocates in the High Court of Bombay Bench at Mumbai, Aurangabad and Nagpur.

The Secretary, Admissions Regulating Authority also submitted that Adv. Murar Deshpande is appearing at Aurangabad Bench, for the Pravesh Niyamtran Samiti/Admissions Regulating Authority, since the year 2006 with legal fees of Rs. 10,000/- Per Month, Adv. Murar Deshpande has requested to revise the legal fees at the rate Rs. 25,000/- per matter and has also suggested two names of Advocates, viz. Adv. Mrigesh D. Narwadkar and Adv. Sujit Gangadharao Karlekar, to work as Junior Advocates in a panel of Advocates for Aurangabad Bench for Admissions Regulating Authority.

The list of Advocates who are appearing at present for the Pravesh Niyamtran Samiti/Admissions Regulating Authority in the High Court of Bombay bench at Mumbai, Aurangabad and Nagpur was placed before the Authority for its perusal.

After detail discussions and deliberations, the Authority decided that the Panel of Advocates should be as follows:-

• **Bombay High Court, Bench at Mumbai**

- i) Adv. Shrinivas Patwardhan would look after for Authority's legal matters as a Senior Advocate and he would suggest names of three other Junior Advocates.

Accordingly the office should obtain the names form Adv. Shrinivas Patwardhan.

• **Bombay High Court, Bench at Aurangabad**

- i) Adv. Murar Deshpande, would look after as a Senior Advocate and as suggested by him,
ii) Adv. Mrigesh Narwadkar &
iii) Adv. Sujit Karlekar,
would work as Junior Advocates.

• **Bombay High Court, Bench at Nagpur**

- i) Adv. Nikhil Gaikwad, would look after as an Advocate. However name of other Advocates would be decided afterwards.

The legal fees would be paid to the Advocates for each case. The legal fees of each Advocate that would be paid per case may be separately decided as per the gravity of the case. The legal fees may vary from case to case.

The Authority further decided to appoint above mentioned Advocates in the legal matters which would arise hereinafter in the Bombay High Court, Bench at Mumbai, Nagpur and Aurangabad in respect of Admissions Regulating Authority and State CET CELL, who would bear the expenses towards the legal fees respectively.

I) Medical Education

SCETCELL/2016/Admission/138, dated 31st December, 2016 informing to the college and explaining that the admissions would not be possible & selection list of suitable candidates couldn't be forwarded on the then existing situation, to the college for admission for Academic Year 2016-17.

The Authority perused the letter 16th December, 2016 received from N.K.P. Salve Institute of Medical Sciences & Lata Mangeshkar Hospital, Nagpur to approve the admissions of students admitted in PG course through PGM/AIPGMEE-CET-2014 for the Academic Year 2014-15. (Ref. Minutes of the Meeting held on 19th October, 2016 Agenda Item No. 5)

The Authority also perused the letter dated 17/01/2017 received from N.K.P. Salve Institute of Medical Sciences & Lata Mangeshkar Hospital, Nagpur and letter dated 17/01/2017 received from AMUPMDC.

The Authority observed that the Institute fails to submit sufficient evidence as to the list of qualified students in APMG-CET-2014 having been exhausted fully for the Academic Year 2014-15, for Post Graduate Medical Courses duly certified by Competent Authority, Association of Management of Unaided Private Medical and Dental Colleges of Maharashtra.

In view of the above, The Authority decides to issue the show cause notice to the above Institute as to why Admission Regulating Authority should not impose the penalty of 10,00,000/- per student while regularizing the admissions done from other than Asso-CET candidates for Academic Year 2014-15 in PG Medical courses of the Institute. The Authority directs the Institute to submit its explanations within four weeks, positively, to the office of the Admissions Regulating Authority. After receipt, of the same it should be placed before the Authority for its consideration.

The Authority observed that the admission of Ku. Kalpita Phand and Ku. Jayantilal Jain has sought the admission in Siddharth College of Law and Dr. Ambedkar College of Law in First Year LLB (3 Years) course respectively. Since both the


